RULES:

1. Contestants must be single, never married, never had a marriage annulled and never had any children and must be Shelby County residents.
2. Contestants must have reached her 13th birthday by October 31 and cannot have reached her 16th birthday by October 31 of the year when the local pageant is held at the local fair.
3. Contestants will be judged from the standpoint of beauty, poise and personality.
4. Contestants will appear in dress, pantsuit or sundress at 9am, Tuesday at the Shelby County Fire Department 200 Alpine Drive, Shelbyville for interview/breakfast with the judges and other contestants.
5. Contestants will appear at 2:00pm Tuesday wearing theme wear. This year's theme is "My Hero" Contestants then will be changing at the fairgrounds into their formal attire. Contestants must appear at 7:00 pm wearing formal wear.
6. Registration fee of \$75.00 to Shelby County Fire Department Ladies Auxiliary (*money order or cash only*) is required along with registration form and a copy of the birth certificate and a **wallet** size photo, to be turned in at informational meeting or mailed to address listed to the right.

7. From the contestants five finalists will be selected. A first runner up and winner will be selected from the finalists. Miss Congeniality will be selected from the contestants.
8. The winner will reign at the Shelby County Fair and must participate in other community related activities, including the "Miss Teen Kentucky County Fair Pageant".
9. The winner will receive \$250.00 cash from the Shelby County A & M Association.
10. All young women who have participated before but have not been named Miss Shelby County Teen may participate again.
11. The Shelby County Ladies Auxiliary under the Auspices of the Shelby County Fair Board will sponsor the pageant.
