

LITTLE MISS AND MISTER SHELBY COUNTY FAIR PAGEANT

Doors Open 8AM - Pageant – 9:00AM

Rules for Eligibility:

1. Contestants register individually; no couples required.
2. Contestant must have reached his/her 5th birthday by June 30, 2020 and cannot have reached his/her 8th birthday by June 30, 2020
3. Contestants must be residents of Kentucky – **open to all Kentucky counties.**
4. Contestant may have participated before but must not have been named Little Miss/Mister Shelby County Fair in previous participation, must not have been crowned Little Miss/Mister Kentucky County Fair, and must not currently hold a Little Miss/Mister title at another member fair for 2020 season.
5. Immediate family of the Shelby County Fair Board are not eligible.
6. Contestants must arrive dressed/ready for competition by 8:30AM for check in and temperature check.
7. Contestants will compete on stage at 9:00AM
8. Registration fee of \$20/person **payable to Shelby County A&M Association**; registration form; copy of birth certificate and headshot/photo of each contestant to be turned in at the informational meeting or mailed to **address listed below** and must be RECEIVED no later than August 20, 2020. Registration is non-refundable. Participation is by Pre-Registration ONLY!
9. Temperatures will be taken upon arrival. No one with a fever will be allowed to compete.
10. There will be an on stage question; this will be age appropriate (example: what is your favorite thing to do? what do you want to be when you grow up?, etc.)
11. The winner will reign at Shelby County Fair. There will **NOT be a state pageant for the 2020 season.** Little Miss and Mister will both be expected/required to participate in other community-related activities including Shelby County Christmas Parade and returning to crown his and her successors at the 2021 pageants.
12. If the winner is unable to complete his/her reign/responsibilities her title shall be removed and reappointed to the first-runner up for the remainder of the term.
