

# MISS SHELBY COUNTY FAIR PAGEANT

Sponsored by Shelby County A&M Association

Monday June 15, 2020

Interview – 4:30PM \* Pageant – 6:00PM

## Rules for Eligibility:

1. Contestants must be single, never married, never had a marriage annulled, and never had any children.
2. Contestant must have reached her 16th birthday by October 31, 2020 and cannot have reached her 22nd birthday by October 31, 2020.
3. Contestant must be a resident of Kentucky – Fair title **open to all Kentucky counties**. Local title also awarded
4. Contestant may have participated before but must not have been named Miss Shelby County Fair in previous participation, must not have been crowned Miss Kentucky County Fair, and must not currently hold a Miss title at another member fair for 2020 season.
5. Contestants will appear in Interview Attire (Business dress, pantsuit, etc.) for 5-minute interview at Horse Show Office  
Interview Time: 4:30PM \* Arrival Time – 4:15PM – **Come ready!**
6. Contestants will appear on stage THREE times at the horse show pavilion. Competition: 6:00PM \* Arrival Time – 5:45PM
  - a. Opening number/Introduction– Theme Wear will be FAIR WEAR - Summer Casual Outfit
  - b. Swimwear – One-piece pageant swim suit – sarong optional
  - c. Formal wear – Floor length formal gown, age appropriate
7. Registration fee of \$100 **payable to Shelby County A&M Association**; registration form; copy of birth certificate and wallet size headshot/photo to be turned in at the informational meeting or mailed to the address listed. Registration is non-refundable. Participation is by Pre-Registration ONLY!
8. Gate fees/admission is not included in registration
9. Contestants will be judged from the standpoint of beauty, poise and personality.
10. Miss Congeniality will be selected from all contestants and voted on by peers and will receive a gift from the committee
11. There will be a People's Choice/Fan Favorite winner chosen by the crowd, during the stage competition. Votes are \$1 each and can be turned in at the designated space during the pageant. Miss Fan Favorite will receive a sash and crown.
12. From the contestants, five finalists will be selected by top scores from all legs of competition. A first runner up and two queens will be selected by the judges from these finalists.
  - a. Miss Shelby County Fair – This title is open to all contestants from all Kentucky counties. Miss Shelby County Fair will reign at Shelby County Fair and must compete at the Miss Kentucky County Fair Pageant in January 2021. She will be **required** to attend the Little Miss and Mister Pageant at Kentucky State Fair and Kentucky State Fair Opening Day Ceremonies
  - b. Miss Shelby County – This local title is open to Shelby County residents only. This queen will be selected as the local contestant with the highest score who is not either the queen or runner up to the Miss Shelby County Fair title. Miss Shelby County fair will reign in her hometown.
  - c. BOTH queens will be expected to participate in other community-related activities including but not limited to: Shelby County Fair Horse Show June 17-22, 2020 and Shelby County Christmas Parade. .
13. The winner will reign at Shelby County Fair and must compete at the Miss Kentucky County Fair Pageant in January 2021 and will be expected to participate in other community-related activities including Shelby County Fair Horse Show June 17-22, 2020 and Shelby County Christmas Parade, Little Miss and Mister Pageant at Kentucky State Fair and Kentucky State Fair Opening Day Ceremonies.
14. If the winner is unable to complete her reign/responsibilities her title shall be removed and reappointed to the first-runner up for the remainder of the term.
15. The fair title winner will receive crown, sash, flowers and \$250 from the Shelby County A&M Association, and two-night hotel reimbursement for state competition (hotel only, up to \$300, no other fees, room service, etc.)
