Rules for Eligibility:

1. Contestants must be single, never married, never had a marriage annulled, and never had any children.
2. Contestant must have reached her 8th birthday by June 30, 2018 and cannot have reached her 13th birthday by October 31, 2018.
3. Contestant must be a resident of Kentucky – open to all Kentucky counties.
4. Contestant may have participated before, but must not have been named Miss Shelby County Pre-Teen in previous participation, and must not have won a Preteen title at another member fair for 2018 season.
5. Contestants will appear in dress, pantsuit or sundress at Floral Hall for interview/breakfast with judges and other contestants. Breakfast 9:00am – Arrival Time – 8:45am.
6. Contestants will appear in theme wear at Bradley Barn during competition. This year's theme is Small Town America/Country Wear. Competition 1:00pm * Arrival Time – 12:45pm
7. Contestants will appear in formal wear at Bradley Barn during competition. Formal Wear Competition 6:00pm * Arrival Time – 5:45pm
8. Registration fee of \$50 payable to Shelby County A&M Association; registration form; copy of birth certificate and wallet size headshot/photo to be turned in at the informational meeting, or mailed to the address listed.
9. Contestants will be judged from the standpoint of beauty, poise and personality.
10. From the contestants, five finalists will be selected. A first runner up and winner will be selected from the finalists. Miss Congeniality will be selected from the contestants.
11. The winner will reign at Shelby County Fair and must compete at the Miss Pre-Teen Kentucky County Fair Pageant in October and will be expected to participate in other community-related activities including Shelby County Fair Horse Show June 19-23.
12. If the winner is unable to complete her reign/responsibilities her title shall be removed and reappointed to the first-runner up for the remainder of the term.
13. The winner will receive crown, sash and \$100 cash from the Shelby County A&M Association.
