RULES:

1. Contestants must be single, never married, never had a marriage annulled, never had children and must be a resident of the state of Kentucky.
2. Contestants must have reached her 13th birthday by October 31 and cannot have reached her 16th birthday by October 31st of the year when the local pageant is held at the local fair.
3. The contestants will be judged from the standpoint of beauty, poise, and personality.
4. Contestants will appear in dress, pantsuit or sundress at 9 am Tuesday, June 12 in Floral Hall on Shelby County Fairgrounds for interview and breakfast with judges and other contestants.
5. Contestants will appear at 2 pm Tuesday in the Bradley Barn wearing theme wear. This year's theme is Small Town America/Country Wear. Contestants then will change into formal attire at the fairgrounds and appear in the Bradley Barn at 7 pm.
6. Registration fee is \$75 made payable in check to Shelby County A & M Association and needs to be submitted with the registration form, a copy of birth certificate and a wallet size photo to be mailed to: **Dawn Morhet, 100 Parkview Drive, Louisville, KY 40245. Deadline for registration is June 4, 2018.**
7. From the contestants five finalist will be selected. A first runner up and winner will be selected from the finalist. Miss Congeniality will be selected by the contestants.
8. The winner will reign at the Shelby County Fair and must participate in other community activities including but not limited to the Shelby County Fair Horse Show (the following week), the Shelby County Christmas Parade and the Miss Teen Kentucky County Fair pageant.
9. The winner will receive \$150 from the Shelby County A & M Association, roses compliments of Pathelen's Flowers and Gift Shop, a tiara compliments of Carol and Co. Fine Jewelry. Miss Congeniality will receive a gift from the pageant committee.
10. Contestants may not have won at another member fair in 2018 or have won the same title in previous years.
11. The Shelby County A & M Association Fair Board sponsors the pageant.
